विषय: Commencement of Registration with National Open Access Registry (NOAR) platform for Open Access in Interstate Transmission System

महोदय,

Hon'ble Central Electricity Regulatory Commission vide dated 02nd January 2019 had notified Open Access in Inter State Transmission Regulation, 2008, fifth amendment to operationalize Open Access through NOAR. As per clause 3A (3) of the said regulation, NLDC has been nominated as the nodal agency for implementation and operation of NOAR.

NOAR shall be a common electronic platform for automatic administration of the Short Term Open Access (STOA) in interstate transmission system (ISTS), providing single window electronic platform to the stakeholders, including short term customers, trading licensees, Power Exchanges, NLDC, RLDCs, SLDCs and Regional Power Committees in connection with STOA in ISTS.

In order to facilitate hand holding and ease of operation, a pan India training program for Open Access users was arranged by POSOCO on 11th October 2021 and 18th October 2021. The 'USER MANUAL' for registration with new NOAR platform has been developed and attached as **Annexure-I** and **Annexure-II**.

As per the implementation plan, the registration module shall be deployed 2 to 3 months prior to Go-Live of the NOAR project. Accordingly, POSOCO is pleased to inform that registration for pan India NOAR platform is scheduled to commence from 1st November 2021. NOAR being a single window to avail Open Access in ISTS, it is mandatory to get registered with the NOAR platform to avail Short Term Open Access in the Interstate Transmission System. The NOAR application is available at <https://noar.in>. The commencement of payment towards registration fees will be intimated in due course before Go-Live of the NOAR platform.

Accordingly, all entities who would like to avail Short Term Open Access in Inter State transaction are requested to register themselves in the NOAR portal.
